The legal voters of Dorset Fire District No. 1, Vermont are hereby notified and warned to meet at Dorset Town Offices, 112 Mad Tom Road, in the Town of Dorset on Tuesday, March 2, 2021 between the hours of ten o'clock (10:00) in the forenoon (a.m.), at which time the polls will open, and seven o'clock (7:00) in the afternoon (p.m.), at which time the polls will close, to vote by Australian ballot upon the following Article of business:

ARTICLE I

Shall general obligation bonds of Dorset Fire District No. 1 in amount not to exceed Five Million Dollars (\$5,000,000), subject to reduction from available state and federal construction grants-in-aid and other financial assistance, and the application of \$700,000 of proceeds of bonds authorized on May 14, 2018, be issued for the purpose of constructing water system source, storage, treatment, transmission and distribution improvements, such improvements estimated to cost Five Million Dollars (\$5,000,000)?
